## **BELGRANO & CO has advised the shareholders of Vogelpark Walsrode GmbH on the sale to Parques Reunidos S.A.**

**Walsrode - January 30, 2019.** Parques Reunidos, a Spanish, publicly listed global operator of over 60 different leisure facilities such as theme parks, zoos, aquariums, water parks, indoor entertainment facilities, has acquired 100% of the assets of Vogelpark Walsrode GmbH ("**Weltvogelpark Walsrode**") via asset deal from the Belgian shareholder Floralux N.V.

With this acquisition, Parques Reunidos strengthens its existing activities in Germany. Parques Reunidos intends to expand the current activities of Weltvogelpark Walsrode and to attract a wider target group in the future.

### **About Weltvogelpark Walsrode**

Weltvogelpark Walsrode was founded in 1962 and is the world's largest bird park with over 675 bird species and more than 4,000 birds.

The 230,000 yearly visitors can experience and observe birds from five continents in different surroundings. In addition to daily interactive bird feedings and air shows, the park offers a 24ha park with a unique flora. A special highlight are baby birds, which can be observed from March to August.

Weltvogelpark Walsrode not only offers its visitors a special recreational experience, but also provides protection for endangered bird species and reproduction programs. The bird keepers take care of every single bird, this is clearly noticeable to the visitor during the daily bird feedings.
